BRIEF HISTORY OF THE INSTITUTE

The Chartered Institute of Transport Administration of Nigeria (CIOTA) formerly known as the Institute of Transport of Nigeria (IOTA), is the leading and premier Chartered professional transport body in Nigeria providing training, membership and certification of transport professionals. First established in Great Britain, United Kingdom in 1944 as a professional body dedicated to promoting education to serve the emerging requirements of transport administration.

It was incorporated in Nigeria in September, 1986 under the Land Perpetual Succession Act Cap 98 with the sole aim of promoting education and the standards of knowledge in controlling and regulating the practices of efficient transport management and administration.

CIOTA CHARTER AND THE PROFESSIONAL TRANSPORT ADMINISTRATOR

The Chartered Institute of Transport Administration of Nigeria establishment Act was enacted as an Act of National Assembly on the 22nd May, 2019 and gazette with Federal Government Act No.27 of 2019 - as a Body corporate with perpetual secession, charged with the responsibility of advancing the study, training and practice of transport management and administration in Nigeria; and for other related matters.

The Act confers a sectoral professional regulatory responsibility on CIOTA, making it the prime pioneer institute in the Transport sector in Nigeria. In addition to the above stated responsibilities, CIOTA has also been approved to set up a Council for the Registration of Transportants (CORTRANS), having the powers to regulate and control the practice of professional transport management and administration in ALL ITS RAMIFICATIONS in Nigeria.

OUR VISION

To develop the transport profession, maintain professional standards and improve the skills of transport practitioners, enabling them to deliver exceptional value for their organisations.

OUR MISSION

To advance the study, training and regulation of the practice of transport management and administration; and other related matters in Nigeria.

THE INSTITUTES AIMS AND CORE MANDATE

The primary aim and objectives of the Institute is to advance the study, training and practice of transport management and administration in Nigeria regardless of specialization within the industry; and to set standards of practice and determines the knowledge and skills to be attained by persons seeking to become registered members of the institute and practice as a Chartered Transportant.

To promote continuing education through conferences, seminars, work visits and research in all aspects of transport management and administration; and also provide professional training for persons aspiring to qualify and practice as a professional transport administrator herein refers to as transport ants in Nigeria.*

Provide Continual Professional Development Programme (CPD) and promote social and networking events including forums to share best practices, views and opinions.

To hold professional examinations, award Certificates, Diplomas, and License to those seeking to become professionally qualified transport administrators.

CODE OF ETHICS OF THE INSTITUTE

The Fundamental Principles

As a registered member of the Institute, you are required to conduct yourself in a professional manner and as well maintain high degree of integrity, impartiality and professionalism when dealing with your professional colleagues, clients and members of the public. It is your responsibility to ensure that the interests of the institute are maintained in your dealing with outside organisations.

The Fundamental Canons

- I. To observe and adhere strictly to the code of ethics and core values of the institute.
- II. To remain loyal to the authority of the institute.
- III. To pay the annual subscriptions as at when due.
- IV. To pay promptly all other dues and levies as may be approved by the council.
- V. To avoid undue interference with the governance and management of the institute.
- VI. To attend meetings, conferences, mandatory programmes and other social events where members are invited.
- VII. To use your knowledge and skills for the advancement of the transport profession; being honest and impartial, and serving with fidelity the public, their employers and clients. And avoid any act either in your place of work for any other places in the society that is likely tarnish the image of the institute.

MEMBERSHIP OF THE INSTITUTE

In accordance with the provisions of Section 4(1) of the establishing Act, individuals admitted to the membership of the Institute must be registered as members and possess adequate knowledge, experience, and qualifications in the field of intermodal transportation and related disciplines specified under this Act. Members will be enrolled in one of the following categories:

- A) Fellows
- B) Members
- C) Associate
- D) Affiliate
- E) Graduate
- F) Students
- G) Corporate (Institutional) Members

A. CRITERIA FOR FELLOW MEMBERSHIP

Eligibility Requirements:

1. Membership Duration:

- " Applicants must have held the grade of "Full Membership" for a minimum of 10 years.
- " They should have demonstrated outstanding service to the Institute over this period.
- " There should be an evidence of participation in most of the Institute programs.
- " Applicant must be recommended by two existing fellow of the Institute.

2. Professional Experience:

- Applicants must be transport practitioners aged 40 years or above.
- They must possess approved academic qualifications and have a minimum of 15 years of continuous experience in the management and administration of transport and logistics functions.
- This experience should be at a senior executive or directorate level within a substantial organization in the transport sector or an allied field.

3. Governing Council Evaluation:

- Applicants must be deemed fit and proper by the Governing Council and should have rendered special or outstanding service to the Institute or the industry as a whole.
- There will be no direct awards of Fellow status to non-members unless specifically requested and approved by the Governing Council.
- Condition for direct fellow by the Governing council shall include the applicant must be a CEO of a transport or logistics organization.
- The Applicants must be an accomplished professional in the field of transport and logistics having contributed to the development of either the Institute or transport profession.
- Honorary Fellowships:
- The President/Chairman of the Council has the authority to award honorary Fellow status to individuals who have distinguished themselves in the field of transport and have significantly contributed to the development of the Institute or transport and logistics profession.
- Financial Obligations:
- All fellow awardees must pay a development levy, as determined by the Governing Council. Fellow awardees are required to pay annual subscription fees for a period of two years in advance.

B. CRITERIA FOR FULL MEMBERSHIP APPLICATIONS

Eligibility Requirements:

- Shall have been an Associate Member
- Must be actively engaged in the practice of Transportation,
- Shall have satisfied all the requirements for Full Membership of the CloTA as stipulated in the Bye-Laws.
- Shall have had at least five years approved post qualification practical experience after which they must have passed the Professional Practice Competence Examination of the Institute, and shall also fulfill any other condition(s), which may be required by the Governing Council.
- Applicants must have successfully completed the final level qualifying examinations conducted by the Institute, including a research project. Or Completed membership enrolment examination and interview with a pass mark of 70 percent pass mark.
- They must demonstrate the ability to function effectively in high managerial positions within the transport industry.
- They must have been in Transport and or logistics business or organization for a minimum of ten years.

1. Professional Experience:

- Applicants must be transport practitioners aged 40 years or above with approved academic qualifications.
- They should have at least ten (10) years of continuous experience in the transport industry, allied organizations, or Armed Services, with five (5) of those years in senior management roles.
- Applicants must be deemed fit and proper individuals by the Council.

Academic Requirements:

- ## **2. All direct Membership applications must be a graduates of Transport, logistics or Transport-related programs, regardless of the applicant's experience.**

C. CRITERIA FOR ASSOCIATE MEMBERSHIP ENROLMENT

Eligibility Requirements:

Associate Member:

Applicants to this grade shall satisfy the following condition:

- Associate Members shall be holders of an accredited Degree or equivalent qualification in Transportation or Transport related course obtained from any recognised Institution in the Federation or abroad and who shall satisfy all the conditions for admission to Associate.

1. Academic Qualifications:

- Applicants must be a Graduate who have successfully passed the professional Level Three qualifying examination conducted by the Institute or hold equivalent qualifications from recognized institutions of higher education.
- Applicants must be deemed fit and proper individuals by the Council.

2. Professional Experience:

- Applicant must be transport practitioner age 30 years and above.
- The should have at least five years consecutive service in transport or transport related industry, or armed forces or institution of learning at a middle level category.
- the council must find the applicant to be fit and proper person.

Exclusions:

- Applicants with a maximum of 10 years of work experience in transport, logistics, or other related fields in-respective of course of study will be considered for the Associate category and qualify for written and oral examination.

D. CRITERIA FOR AFFILIATE CATEGORY

Eligibility Requirements for Registration as a Transport Craftsman/Technicians (Affiliate category)

Category I: Holders of WAEC Technical, NABTEB (Transport/logistics-related), and Trade Test Certificates.

Transport Craftsman/Technicians (Affiliate Category)

Requirements:

1. Submission of Application: Must be submitted through the CloTA online Registration Portal.
2. Certified Copies of Transport/Logistics Qualifications: Provide certified copies of related educational qualifications.
3. Professional Competency Profile: The candidate must present a competency profile, including a Certificate of Experience sheet available on the CIOTA website.
4. Passing the Professional Exam: Must have passed a professional examination administered by CloTA.
5. Certified True Copy of Transport/Logistics Qualifications: Present a certified true copy of a National Association of Transport Engineers, technicians, Certificate (NAET) or equivalent.
 1. WAEC Technical / NABTEB (Transport/logistics-related).
 2. Trade Test Grade I.
 3. Craft Certificate in Transport and Logistics from City & Guilds or an equivalent certification.

E. CRITERIA FOR GRADUATE MEMBERSHIP ENROLMENT

Eligibility Requirements:

1. Academic Qualifications:
 - Applicants must possess a first degree-or HND in transport or allied disciplines that is accredited by the Institute.
 - Alternatively, applicants may have completed an accredited conversion course, provided that at least 60% of the coursework is related to transportation and logistics studies.
2. Application Process:
 - Initial applications should normally be accompanied by certificates qualification and transcript(s).

Exemption from Examination:

Graduate members are not required to undergo an examination before being considered for the Associate category.

F. CRITERIA FOR STUDENT MEMBERSHIP

Eligibility Requirements:

1. Examination Registration:

- Applicants must be registered for the CIOTA Professional Qualifying Examination scheme or registered as a Student undergoing study in transport, logistics or transport related programs.

2. Academic Qualifications:

- Applicants should have a minimum of five (5) credits in the SSCE, NECO, or GCE O'Level examinations, including English Language and Mathematics or their equivalents.

3. Undergraduate Status:

- Students currently enrolled in a course of study in transport studies at tertiary institutions in Nigeria or abroad are eligible for students' membership

All students registered for recognized training schemes in transport studies shall become professional members only after passing the prescribed examinations as approved by the Council or the Institute's by-laws.

G. CRITERIA FOR CORPORATE MEMBERSHIP

Eligibility Requirements:

1. Corporate Status:

- Applicants must be a corporate body and must satisfy the Council that they are eligible for registration.

2. Compliance with Council Criteria:

- Applicants must meet all other criteria specified by the Council from time to time.

3. Entitlements:

- A corporate member of the Institute shall be entitled to receive a certificate and a plaque from the Council, presented in a form determined by the Council.

Membership Categories:

- All corporate applicants will have the opportunity to choose their preferred categories of membership.

Financial Obligations:

- Corporate members are required to pay annual subscriptions at a rate determined by the Governing Council.

GENERAL REQUIREMENT FOR ENROLMENT OF MEMBER EXAMINATION AND INTERVIEW PROCESS FOR ALL APPLICANTS

- All applicants for Membership will be required to undergo intensive training and written examinations conducted by the Training and Education Committee of the Institute, with a pass mark of 75% for membership category and 60 % for Associate category.
- All applications, submission and processing will be online. Following the examination, an interview will be conducted by the Membership and Planning Committee before approval of membership.

General Procedure for Professional Examination:

- 1. Oral Interview:** Candidates will undergo an oral interview to assess their professional competencies.
- 2. Interview Duration:** The interview will generally last between 20 and 30 minutes, conducted by at least two expert panel members with a minimum of ten years of professional experience in the transport sector.
 - 1. Presentation:** Candidates will be given 5 to 10 minutes at the beginning of the interview to provide a brief, uninterrupted verbal presentation about their professional competencies.
- 2. Panel Focus:** After the presentation, the panel will ask questions related to the candidate's area of expertise, based on the application.

3. **Confidentiality:** The panel members are bound by CIOTA's code of ethics to maintain confidentiality regarding the assessment and any provided information/data.

Induction Process:

- " Induction into the all categories of Membership of the Institute shall be carried out twice a year: mid-year and at the end of the year during the annual national transport conference.
- " Special inductions may be carry out base on need assessment.
- " Financial obligations by all new Members
New members must pay two years' annual subscriptions in advance prior to induction.
- New members are required to pay non-refundable examination fees depending on the category of membership

PROFESSIONAL QUALIFYING EXAMINATION AND CERTIFICATION

The institute's professional examination is designed to provide a standard of education from which candidates can both build and develop a worthwhile practical career in transport management and administration AT ALL LEVELS. Below are the four stages of professional qualifying examinations which are held in June and December each year.

ENTRY REQUIREMENTS

Every applicant for registration as student will be required to submit acceptable evidence that he/she has obtained an approved educational qualification. The following educational qualification will be accepted for this purpose.

A. FOUNDATION CERTIFICATION EXAMINATION

1. Five (5) Credit passes in GCE O'Level/SSCE or its equivalents. The subject passed must include English Language and Mathematics, and any other subjects, preferably Economics and Geography
2. Four (4) Credit passes in GCE O'Level/SSCE or its equivalents will be accepted in the case of Mature Candidates, provided English Language and Mathematics are included in the subjects passed

B. PROFESSIONAL DIPLOMA EXAMINATION

1. CIOTA Foundation Certificate Examination/intermediate Certificates of a recognized Professional body
2. A Recognised/Accredited Diploma in Economics, Geography, Accountancy, Marketing, Business Studies, Travel & Tourism, Freight forwarding e.t.c.

C. PROFESSIONAL ADVANCED DIPLOMA EXAMINATION

1. CIOTA Professional Diploma/Professional Diploma of a recognized body or allied institution
2. Advanced Diploma, HND, B.Sc, PGD/MBA and other relevant qualifications of equivalent

status in Economics, Marketing, Accounting, Business Administration, Engineering, Law e.t.c., with at least 2 years of working experience.

D. PROFESSIONAL GRADUATE DIPLOMA FINAL LEVEL EXAMINATION

1. CloTA Professional Advanced Diploma or the final Examination Certificate of a recognized allied bodies in Transport
2. HND, B.Sc, PGD/M.Sc/MBA from a recognised institution and other relevant qualifications of equivalent status in Transport Studies, Geography, Urban & Regional Planning, Logistics & Supply Chain, Transport Engineering and International Trade with at least 2 years working experience.

E. PROFESSIONAL CERTIFICATION AND LICENSING

Please note that Curriculum Vitae to show professional work experience must be attached.

ELIGIBILITY

Successful completion of the Professional Graduate Diploma Final Stage Examination, with research project and internship qualities a candidate for the award of "Full Membership" of the institute; and confers eligibility to apply for registration as a Chartered Transportant and to apply for a range of postgraduate programmes at Universities in Nigeria and Overseas.

To complete the Final Level Qualifying Examination, candidates will also be required to complete a professional research project in transport. The Project is the academic equivalent of a good university first degree project in Nigeria and Overseas. Successful completion of the Final stage examination, with research project and internship qualifies a candidate for the award "Full Membership" of the institute; and confers eligibility to apply for registration as a Chartered Transportant and also for a range of postgraduate programmes at various Universities in Nigeria and Overseas.

THE CHARTERED TRANSPORTANTS CERTIFICATION (CTN)

This is the Professional Transport Managers and Administrators* (CTN) certification program, designed for candidates who have a wide-range of education and experience in Transport discipline. It is the only certification program in Nigeria specifically addressing the work performed by transport professionals. By earning the Chartered Transportants (CTN) designation, you join a group of transportation professionals who have acquired requisite knowledge and skills in the practice of Transport management and administration, and who are registered under the category of full Membership of the Chartered Institute of Transport Administration of Nigeria.

The CTN status indicates professional recognition and competence, from peers and employers, of significant experience and capability to plan, implement, manage and evaluate the potential of future actions to improve transport management initiatives. The integrity of the profession is reinforced by the upholding of a code of conduct that ensures the highest standard of integrity, ethics and professionalism.

REQUIREMENTS

To be certified as a Chartered Transportant* the candidate must meet all of the following requirements:

1. Be an active member of CIoTA who maintains current and up to date minimum of the Full Membership of the institute, attained through the final professional qualifying examinations stages.
2. Have an accredited Master's or Ph.D. degree in Transport Management, Transport Engineering, Transport Economics, Maritime Management, Marine Engineering, Aeronautical Engineering, Aviation Management, Transport Planning, Traffic Management and Administration, Logistics and Supply Chain Management or other allied disciplines with three years of professional work experience in transport and allied industry.
4. Have an accredited Bachelor's degree in a transportation discipline with five years of

professional work experience in transportation, or have an accredited bachelor's degree in a non-transportation course of study with Seven years of professional work experience in transportation, logistics and allied industry; in all these cases, the candidate must also pass the prescribed qualifying examination of the institute, or be exempted from it.

5. Has no conviction for offences related to fraud, corruption or professional misconduct
6. Take and attain a passing score on the Chartered Transportant examination or exempted from it; and;
7. Have paid the application/examination fee and the three-year certification fee.

MEMBERSHIP APPLICATION PROCEDURE

Prospective members of the institute must obtain the membership application form @ N5,000, provide all the details in the form and as well pay in full all annual subscription and other prescribed fees upon joining. Completed application forms are to be returned together with the following documents to the institute for processing by the Membership Committee.

1. Two recent passports size photo of the applicant;
2. A copy of the curriculum vitae (CV) detailing proof of employment / profession, in any form;
3. A copy of academic achievements (e.g certificates of graduation) and copies of proof of Membership with other professional institutes, if any;and
4. Duly completed and signed application form.
