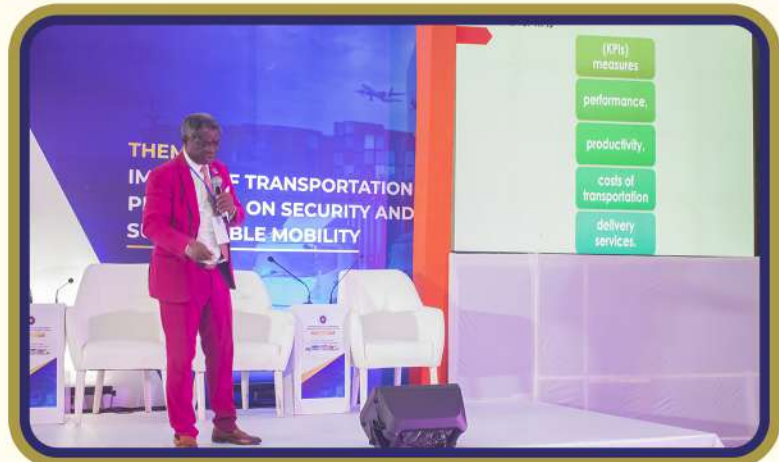

Dr. Umesi Emenike's presentation on "Risk Management, Control, and Preparedness" was particularly enlightening, providing attendees with valuable insights in the field.

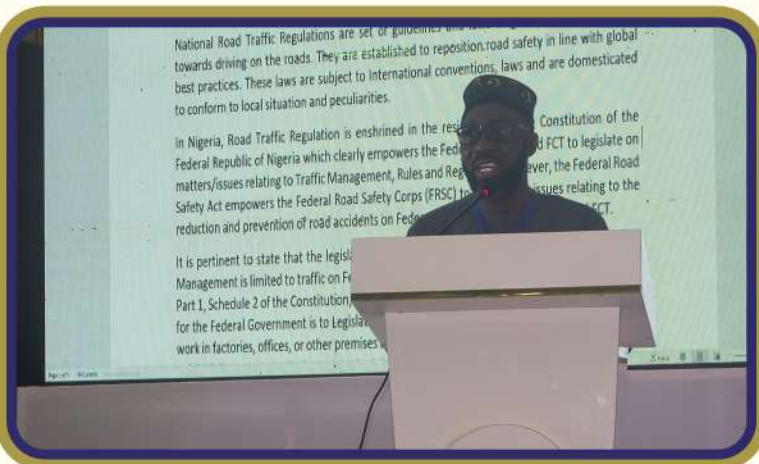
